CHECKS SHALL BE MADE PAYABLE TO VILLAGE OF CELORON BUT SENT TO AVALON AT THE ADDRESS ABOVE.

CONTACT AVALON IN ADVANCE FOR PICK-UP, OR TO PROVIDE SHIPPING ACCOUNT INFORMATION FOR EXPEDITED DELIVERY. IF BID DOCUMENTS ARE TO BE SHIPPED, THE BIDDER MUST FURNISH AVALON WITH THE BIDDER'S ACTIVE UPS OR FEDERAL EXPRESS ACCOUNT NUMBER OR PAY AVALON FOR ALL SHIPPING AND HANDLING COSTS.

A BIDDER, MAKING THE DEPOSIT REQUIRED FOR THE BIDDING DOCUMENTS, SUBMITTING A PROPOSAL ACCOMPANIED BY A CERTIFIED CHECK OR OTHER SECURITY IN ACCORDANCE WITH THE REQUIREMENTS CONTAINED IN THE PLANS AND SPECIFICATIONS AND PUBLIC ADVERTISEMENT FOR BIDS AND IF THE COPY OF THE PLANS AND SPECIFICATIONS USED BY SUCH BIDDER, OTHER THAN THE SUCCESSFUL BIDDER IS RETURNED IN GOOD CONDITION WITHIN THIRTY (30) DAYS TO AVALON (ADDRESS ABOVE) AWARD OF THE CONTRACT COVERED BY SUCH PLANS AND SPECIFICATIONS, OR REJECTION OF THE BID, THE FULL AMOUNT OF SUCH DEPOSIT FOR ONE COPY OF THE PLANS AND SPECIFICATIONS SHALL BE RETURNED TO SUCH BIDDER, INCLUDING THE SUCCESSFUL BIDDER. PARTIAL REIMBURSEMENT, IN AN AMOUNT EQUAL TO THE FULL AMOUNT OF SUCH DEPOSIT FOR ONE SET OF PLANS AND SPECIFICATIONS PER UNSUCCESSFUL BIDDER OR NON-BIDDER LESS THE ACTUAL COST OF REPRODUCTION OF THE PLANS AND SPECIFICATIONS, SHALL BE MADE FOR THE RETURN OF ALL OTHER COPIES OF THE PLANS AND SPECIFICATIONS IN GOOD CONDITION WITHIN THIRTY (30) DAYS FOLLOWING THE AWARD OF THE CONTRACT OR THE REJECTION OF THE BIDS COVERED BY SUCH PLANS AND SPECIFICATIONS.

EACH BID MUST BE ACCOMPANIED BY A BID BOND OR CERTIFIED CHECK IN THE AMOUNT OF FIVE PERCENT (5%) OF THE AMOUNT OF THE BID, DULY EXECUTED BY THE BIDDER AS PRINCIPAL, AND HAVING AS SURETY THEREON A SURETY COMPANY APPROVED BY THE OWNER. PERFORMANCE BOND AND PAYMENT BOND EQUAL TO 100% OF THE CONTRACT SUM ARE REQUIRED TO BE DELIVERED AT TIME CONTRACT IS SIGNED WITH OWNER.

MINORITY AND WOMEN-OWNED BUSINESS ENTERPRISES (MWBE) ARE ENCOURAGED TO RESPOND. FUNDING FOR THIS PROJECT IS BEING PROVIDED BY THE NEW YORK STATE DEPARTMENT OF STATE (NYS DOS) WITH FUNDS PROVIDED UNDER TITLE 11 OF THE ENVIRONMENTAL PROTECTION FUND. THE SELECTED CONTRACTOR MUST COMPLY WITH ALL PROVISIONS IN THE CONTRACT BETWEEN THE NYS DOS AND THE VILLAGE, INCLUDING THE NYS DOS MWBE GOALS. THE OVERALL MWBE PARTICIPATION GOAL FOR THIS PROJECT HAS BEEN ESTABLISHED AT 30%, WITH 15% PARTICIPATION FROM MINORITY-OWNED BUSINESS ENTERPRISES (MBE) AND 15% PARTICIPATION FROM WOMEN-OWNED BUSINESS ENTERPRISES (WBE). RESPONDENTS ARE EXPECTED TO DEMONSTRATE HOW THEY EXPECT TO ACHIEVE THIS GOAL.

NO BIDDER MAY WITHDRAW THEIR BID WITHIN SIXTY (60) DAYS OF THE DATE OF THE BID OPENING.
