A Public Hearing of the Board of Trustees of the Village of Celoron, New York was held on Monday, February 8, 2021 at 5:45 P.M.

Members Present: Mayor Schrecengost, Trustees Burley, Burnett and Moss

Mayor Schrecengost called the Public Hearing to order and asked the Clerk to read the legal notice.

### **Notice of Public Hearing**

The Village of Celoron will hold a public hearing on February 8, 2021 at 5:45 pm at the Community Center, 47 Dunham Avenue, Celoron NY 14720 for the purpose of hearing public comments on the Village of Celoron's current Community Development Block Grant (CDBG) project: CDBG # 206HR348-18, in the amount of \$489,500, known as the Celoron Village Rehab Program. The CDBG program is administered by the New York State Office of Community Renewal (OCR), and provides resources to eligible local governments for housing, economic development, public facilities, public infrastructure, and planning activities, with the principal purpose of benefitting low/moderate income persons. The hearing will provide further information about the progress of the ongoing CDBG project. Comments related to the effectiveness of administration of the CDBG project will also be received at this time. The hearing is being conducted pursuant to Section 570.486, Subpart I of the CFR and in compliance with the requirements of the Housing and Community Development Act of 1974, as amended.

The Community Center is accessible to persons with disabilities. If special accommodations are needed for persons with disabilities, those with hearing impairments, or those in need of translation from English, those individuals should contact Shirley Sanfilippo, Village Clerk at 716-487-4175, at least one week in advance of the hearing date to allow for necessary arrangements.
